State tax credits for eligible businesses mostly manufacturers. In rural areas you must have a minimum of five new employees and one million in investment and pay certain wages with benefits.

Micro-Enterprise Tax Credits https://revenue.nebraska.gov/incentives/microenterprise

Micro-Enterprise Tax credits provide a 20 percent refundable tax credit to micro businesses on increased compensation for employees or increased investment in targeted communities. Applicants may qualify for a maximum of \$10,000. The credit is limited to companies with five or fewer employees at the time the application. Nebraska Department of Revenue application process.
